We would like to request you to ensure fair representation by inducting women in the SDC creation of Gender Cell in Planning Department will also help in engendering development planning.

2. **Separate Child Right Commission and Appointment of Members:-** in the recent times there has been increase in crime against children's therefore, society appeals the government to immediately activate the Child Right Commission by appointing qualified and experience women working with children issues.

3. **Proper verification/monitoring of private schools:-** As you are aware of the fact that in recent past there is mushrooming of private schools in and around Capital Complex and in the district also. The cases of rape and molestation of minor girls by the teacher and school staffs has caused concerned for the society. Therefore, proper verification/monitoring of private schools is need of the hour to check such incident.

4. **De - addiction Centre:-** You will agree that many districts in Arunachal Pradesh are struggling with the problem arising out of opium/drugs addiction. Therefore Society seeks your ardent help in establishment of de - addiction centre in Capital Complex, Changlang, Lohit, Longding, Anjaw, Tirap, Upper Siang and Siang districts.

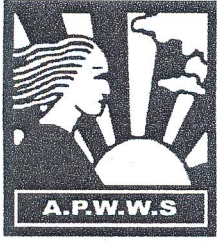
5. **Setting up of Juvenile Homes and Shelters:-** As you are aware that there is only one Juvenile home in the entire State, which is not capable to cater to the needs of State. Therefore, we would like to request you to increase the numbers of Juvenile homes and Shelters in every district headquarters as well as improving the facilities at the lone Juvenile home in Pasighat.

6. **Recruitment of Women Police Officers :-** As you aware there has been considered increase in number of crime against women and children in the State. To contain and pursue such cases, the Society would request the government to recruit more women officers in the State Police. The state needs at least two dozen Deputy Superintendents to help contain/lessen the number of crimes against women.

7. **Fast Tracking of Gender related Cases :-** We would request that cases pertaining to violence against women and Children is fast tracked for early delivery of justice. It has been seen that many cases relating to women and children are pending emboldening criminal.

8. **Old Age Homes and Mental Health Institutions:-** With changing times, the State has witnessed a big increase in nuclear family units. With this changing trends, preferred by the young citizen there seems to be increase in number of old age people who have been fend to left for themselves. The Society seeks that the State Government creates old age homes across the State as the intervention of the State is acutely desired to take care of our aged population.

The Society would also request you to make functional mental health institution in the State which still lying unattended by the Health Department.
